Minutes of the Project Selection Committee Meeting (28th and 29th January 2010)
For the General Grant in Aid Scheme for Innovative Projects

Background

A number of unchartered areas remain that are not currently covered by any of the existing schemes of the Ministry of Women and Child Development (MWCD). To cover a wide spectrum of programme areas for tackling social problems or meeting the needs of specific client groups which have hitherto not been addressed through the schemes of MWCD or other ministries, a general scheme of grant-in-aid (GIA) is implemented which does not transgress the existing grant-in-aid schemes but rather supplements them.

Support within this scheme is given to work that is innovative in nature, i.e. addressing a peculiar problem or working with a client group that has not been previously covered. Keeping with the spirit of innovation, the grant provides support only for one year at a time, with an understanding that the NGO applying for support within the scheme would find other viable sources to sustain the project within this time period.

The PSC for the GIA scheme was held on the 28th and 29th of January 2010, headed by the Secretary, MWCD. The list of PSC members is annexed, Details are as follows:
