I am directed to convey the sanction of President to the payment of Rs.70,52,80,000/- (Rupees Seventy crore fifty two lakh and eighty thousand only) to the following State Governments to the extent of amount indicated against each as grants-in-aid during 2010-11 for implementation of Non-nutrition component under Rajiv Gandhi Scheme for Empowerment of Adolescent Girls – Sabla:

2. The State Governments will maintain separate records of expenditure incurred for implementation of Non-nutrition component under Rajiv Gandhi Scheme

for Empowerment of Adolescent Girls (RGSEAG) –‘SABLA’ and furnish separate Statement of Expenditure and Utilization Certificate along with Physical Progress Report every quarter. The information on expenditure on Nutrition Provision from 1st April to 30th June must be furnished by 15th July, for the period from 1st July to 30th September by 15th October, from the period 1st October to 31st December by 15th January and from 1st January to 31st March by 15th April to enable the Ministry to work out the entitlement of Central assistance of each State Government/UT Administration.

3. The payment is provisional and is subject to final adjustment in the light of the audited figures of actual expenditure for the year as a whole. The grant-in-aid is subject to the condition that when the Scheme is closed or abandoned, the proceeds from the disposal of assets built out of the whole or a portion of the grant sanctioned will be shared between the Central and State Governments in proportion with their respective shares in the capital cost to assets.

4. The expenditure is debitable to the Major Head `3601": Sub-Head; 04-Grants for Centrally Sponsored Plan Schemes, 04.358-Social Welfare-Child Welfare, 08-Rajiv Gandhi Scheme for Empowerment of Adolescent Girls (RGSEAG), 08.00.31-Grants-in-aid – General in Demand No. 104 Ministry of Women & Child Development 2010-11 (Plan).

5. The amount of grant-in-aid is finally adjustable in the books of the Principal Pay and Accounts Office, Ministry of Women & Child Development, D, Wing, Ground Floor, Shastri Bhawan, New Delhi. The payment of the State would be arranged through the Reserve Bank of India, Nagpur. The State Accountant Generals will send intimation regarding receipt of grant-in-aid to the Principal Pay & Accounts Office, Ministry of Women & Child Development, Shastri Bhawan, D Wing, Ground Floor, New Delhi.

6. The pattern of grants has been approved by the Ministry of Finance. This sanction is being issued in conformity with the rules and principles of the scheme approved by the Competent Authority.

7. This sanction issues with the concurrence of IFD vide their Dy.No.1785/AS&FA Dated 15.2.2011.
