Sir,

I am directed to convey the sanction of President to the payment of Rs.2,69,78,000/- (Rupees two crore sixty nine lakh and seventy eight thousand only) to the following State Governments to the extent of amount indicated against each as grants-in-aid during 2010-11 for implementation of Indira Gandhi Matritva Sahyog Yojana (IGMSY) – Conditional Maternity Benefit (CMB) Scheme:-

The State Governments will maintain separate records of expenditure incurred for implementation of Indira Gandhi Matritva Sahyog Yojana (IGMSY) – Conditional Maternity Benefit (CMB) Scheme and furnish separate Statement of Expenditure and Utilization Certificate along with Physical Progress Report every quarter. The information on expenditure from 1st April to 30th June must be furnished by 15th July, for the period from 1st July to 30th September by 15th October, from the period 1st October to 31st December by 15th January and from 1st January to 31st March by 15th April to enable the Ministry to work out the entitlement of each State Government/UT Administration.

3. This grant-in-aid is towards the Conditional Cash Transfer under Indira Gandhi Matritva Sahyog Yojana (IGMSY). The payment is provisional and is subject to final adjustment in the light of the audited figures of actual expenditure for the year as a whole.

The expenditure is debitable to the Major Head `3601": Sub-Head; 04-Grants for Centrally Sponsored Plan Schemes, 04.356-Social Welfare-Women's Welfare (Minor Head), 06-Indira Gandhi Matritva Sahyog Yojana (CMB Scheme), 06.00.31-Grants-in-aid – General in Demand No. 104 Ministry of Women & Child Development 2010-11 (Plan).

5. The amount of grant-in-aid is finally adjustable in the books of the Principal Pay and Accounts Office, Ministry of Women & Child Development, D, Wing, Ground Floor, Shastri Bhawan, New Delhi. The payment of the State would be arranged through the Reserve Bank of India, Nagpur. The State Accountant Generals will send intimation regarding receipt of grant-in-aid to the Principal Pay & Accounts Office, Ministry of Women & Child Development, Shastri Bhawan, D Wing, Ground Floor, New Delhi.

6. The pattern of grants has been approved by the Ministry of Finance. This sanction is being issued in conformity with the rules and principles of the scheme approved by the Competent Authority.
