Subject: Integrated Child Development Services (ICDS) Scheme – Release of grants-in-aid to State Government of Mizoram during 2010-11 for construction of Anganwadi Centre buildings – II instalment.

Sir,

In continuation to this Department's Sanction letter of even number dated 15th March, 2010, I am directed to convey the sanction of the President to the payment of Rs.5,11,00,000/- (Rupees Five Crore Eleven lakh only) to the State Government of Mizoram as second instalment of grant-in-aid approved for construction of 584 Anganwadi Centre buildings during 2006-07.


2. The terms & conditions as specified in the Sanction letter of even number dated 15th March, 2010 will remain the same.

3. This Grand-in-aid is towards the non-recurring and recurring expenditure for the ICDS Programme. The payment is provisional and is subject to final adjustment in the light of the audited figures of actual expenditure for the year as a whole vide Ministry of Finance letter No.2(19)-P.II/60 dated 9.10.1964, as amended from time to time, addressed to all State Government etc.

4. The Grant-in-aid is subject to the condition that, when the Scheme is closed or abandoned, the receipt from the disposal of assets, built out of the whole or a portion of the grant now sanctioned will be shared between the Governments in proportion with their respective shares in the capital cost to assets.

5. The expenditure is debitable to the Major Head "3601" in Demand No. 104 Ministry of Women & Child Development under Sub-head; 04-Grants for Centrally Sponsored Plan Schemes, 04.358-Social Welfare – Child Welfare, 05-Integrated Child Development Services, 05.01-General Component, 05.01.31-Grants-in-aid (Plan) during 2010-2011.

5. The amount of grant-in-aid is finally adjustable in the books of the Principal Pay and Accounts Office, Ministry of Women & Child Development, A Wing, Sixth




Floor, Shastri Bhawan, New Delhi. The payment of the State would be arranged through the Reserve Bank of India, Nagpur. The State Accountant General will send intimation regarding receipt of grant-in-aid to the Principal Pay & Accounts Office, Ministry of Women & Child Development, A, Wing, Sixth Floor, New Delhi.

6. The pattern of grants has already been approved by the Ministry of Finance. This sanction is being issued in conformity with the rules and principals of the scheme approved by the Ministry of Finance.

7. This sanction issues with the concurrence of IFD vide Dy. No. 1658/AS&FA dated 27.01.2011.


