Sir,

I am directed to convey the sanction of President to the payment of Rs.8,13,20,000/- (Rupees eight crore thirteen lakh and twenty thousand only) to the following State Governments to the extent of amount indicated against each as grants-in-aid during 2010-11 towards GoI's share (50%) for Nutrition Provision under Rajiv Gandhi Scheme for Empowerment of Adolescent Girls (RGSEAG) –‘SABLA’.

2. The State Governments will maintain separate records of expenditure incurred for implementation of Rajiv Gandhi Scheme for Empowerment of Adolescent Girls (RGSEAG) –‘SABLA’ and furnish separate Statement of Expenditure and Utilization Certificate along with Physical Progress Report every quarter. The information on expenditure on Nutrition Provision from 1<sup>st</sup> April to 30<sup>th</sup> June must be furnished by 15<sup>th</sup> July, for the period from 1<sup>st</sup> July to 30<sup>th</sup> September by 15<sup>th</sup> October, from the period 1<sup>st</sup> October to 31<sup>st</sup> December by 15<sup>th</sup> January and from 1<sup>st</sup> January to 31<sup>st</sup> march by 15<sup>th</sup> April to enable the Ministry to work out the entitlement of Central assistance of each State Government/UT Administration.

3. This grant-in-aid is towards the expenditure on nutrition component for the Rajiv Gandhi Scheme for Empowerment of Adolescent Girls (RGSEAG) –‘SABLA’. The payment is provisional and is subject to final adjustment in the light of the audited figures of actual expenditure for the year as a whole.

4. The expenditure is debitable to the Major Head `3601": Sub-Head; 04-Grants for Centrally Sponsored Plan Schemes, 04.358-Social Welfare-Child Welfare, 08-Rajiv Gandhi Scheme for Empowerment of Adolescent Girls (RGSEAG), 08.00.31-Grants-in-aid – General in Demand No. 104 Ministry of Women & Child Development 2010-11 (Plan).


5. The amount of grant-in-aid is finally adjustable in the books of the Principal Pay and Accounts Office, Ministry of Women & Child Development, D, Wing, Ground Floor, Shastri Bhawan, New Delhi. The payment of the State would be arranged through the Reserve Bank of India, Nagpur. The State Accountant Generals will send intimation regarding receipt of grant-in-aid to the Principal Pay & Accounts Office, Ministry of Women & Child Development, Shastri Bhawan, D Wing, Ground Floor, New Delhi.

6. The pattern of grants has been approved by the Ministry of Finance. This sanction is being issued in conformity with the rules and principles of the scheme approved by the Competent Authority.


