The information on expenditure on ICDS (General) from 1<sup>st</sup> April to 30<sup>th</sup> June must be furnished by 15<sup>th</sup> July and for the period from 1<sup>st</sup> July to 30<sup>th</sup> September by 15<sup>th</sup> October and from the period 1<sup>st</sup> October to 31<sup>st</sup> December by 15<sup>th</sup> January and from 1<sup>st</sup> January to 31<sup>st</sup> March by 15<sup>th</sup> April to enable the Ministry to work out the entitlement of Central assistance of the State Government/UT Administration.





1<sup>st</sup> October to 31<sup>st</sup> December by 15<sup>th</sup> January and from 1<sup>st</sup> January to 31<sup>st</sup> March by 15<sup>th</sup> April to enable the Ministry to work out the entitlement of Central assistance of the State Government/UT Administration.


