The expenditure is debitable to the Major Head '3601' in Demand No 104 of Ministry of Women & Child Development under sub-head: 04-Grants for Centrally Sponsored Plan Schemes, 04.358-Social Welfare-Child Welfare, 05-Integrated Child Development Services, 05.03-Supplementary Nutrition, 05.03.31-Grants-in-aid( General) 2010-2011 (Plan).

3. The amount of grant-in-aid is finally adjustable in the books of the Principal Pay and Accounts Office, Ministry of Human Resource Development, D, Wing, Ground Floor, Shastri Bhawan, New Delhi. The payment of the State would be arranged through the Reserve Bank of India, Nagpur. The State Accountant General will send intimation regarding receipt of grant-in-aid to the Principal Pay & Accounts Office, Ministry of Human Resource Development, Shastri Bhawan, D Wing, Ground Floor, New Delhi.

4. The States shall maintain separate accounts and furnish information on actual expenditure incurred on supplementary nutrition every quarter. The information on expenditure on supplementary nutrition from 1<sup>st</sup> April to 30<sup>th</sup> June must be furnished by 15<sup>th</sup> July and for the period from 1<sup>st</sup> July to 30<sup>th</sup> September by 15<sup>th</sup> October and from the period from 1<sup>st</sup> October to 31<sup>st</sup> December by 15<sup>th</sup> January and from 1<sup>st</sup> January to 31<sup>st</sup> March by 15<sup>th</sup> April to enable the Department to work out the entitlement of Central assistance of each State Government/UT Administration.




