2. The State Government will maintain separate records of expenditure incurred for implementation of Kishori Shakti Yojana and furnish separate Statement of Expenditure and Utilisation Certificate alongwith Physical Progress Report.

3. This grant-in-aid is towards the non-recurring and recurring expenditure for the Kishori Shakti Yojana. The Payment is provisional and is subject to final adjustment in the light of the audited figures of actual expenditure for the year as a whole.

4. The grant-in-aid is subject to the condition that when the Scheme is closed or abandoned, the proceeds from the disposal of assets built out of the whole or a portion of the grant sanctioned will be shared between the Central and State Governments in proportion with their respective shares in the capital cost to assets.



5. The expenditure involved is debitable to the Major Head'3601',Sub-Head 04-Grants for Centrally Sponsored Plan Schemes 04.358-Social Welfare-Child Welfare, 05-Integrated Child Development Services 05.04-Kishori Shakti Yojana , 05.04.31-Grants-in-aid in Demand No.104-of the Ministry of Women and Child Development for 2009-10(Plan).

6. The amount of grant-in-aid is finally adjustable in the books of the Principal Pay and Accounts Office, Ministry of Women and Child Development, D-Wing, Ground Floor, Shastri Bhavan, New Delhi. The Payment of the State would be arranged through the Reserve Bank of India, Nagpur. The State Accountant General will send intimation regarding receipt of grant-in-aid to the Principal Pay and Accounts Office, Ministry of Women and Child Development, Shatri Bhavan, D-Wing, Ground Floor, New Delhi.

7. The pattern of grants has been approved by the Ministry of Finance . This sanction is being issued in conformity with the rules and principles of the scheme approved by the Competent Authority.
