Subject:- ICDS Training Programme - Release of 2<sup>nd</sup> instalment of Grants- in -Aid to the State Government of Orissa during 2009-10 for implementation of ICDS Training Programme- Regarding.

Sir,

In continuation of this Ministry's letter of even number dated 25.09.2009 I am directed to convey the sanction of the President of India to the release of grant-in-aid of **Rs. 187.71 lakhs (Rupees one crore eighty seven lakhs and seventy one thousand only)** as **2<sup>nd</sup> instalment** to the State Government of Orissa for implementation of ICDS Training Programme to the Government during the year 2009-10. The grant-in-aid is as per the revised financial norms contained in this Ministry's letter's No. 11-13/2006-TR-1 dated 21.04.2009 regarding administrative approval and guidelines for implementation of ICDS Training Programme.

2. The Payment is provisional and is subject to final adjustment in the light of audited figures of actual expenditure for the year as a whole vide Ministry of Financial letter No. 2 (19) p.II/20 dated 9.10.64, as amended from time to time, addressed to all State Governments, etc.

3. The expenditure is debitable to the Major Head '3601' Grants-in-Aid to State Government; 04-Grants for Centrally Sponsored Plan Schemes(Sub Major Head);358-Social Welfare-Child Welfare (Minor Head); 05 Integrated Child Development Services ; 05.01 General Component ; 5.01.31 Grant-in-Aid (Plan) under Demand No.104 of the Ministry of Women and Child Development for the year 2009-10.

4. The Amount of grant-in-aid is finally adjustable in the books of the Principal Accounts Officers, Ministry of Women & Child Development, New Delhi. Payments to State Government would be arranged through the Reserve Bank of India, Nagpur. The Accountant General will send intimation regarding receipt of the grant-in-aid to the

Principal Accounts Officer, Ministry of Women and Child Development, D- Wing,  
Shastri Bhavan, Ground Floor, New Delhi.

5. The grant is subject to the terms and condition of the scheme of Integrated Child Development Services (ICDS).



6. The State is also requested to do the following:

- (a) Send expenditure reports on a quarterly basis.
- (b) Optimize the training capacity of the existing Training Centers.
- (c) Furnish achievements made against physical targets during 2008-09 on a quarterly basis.
- (d) Match physical progress and financial releases made.

7. Further releases for the subsequent years will be made only after information is received on the above points.
