Subject:- Grant-in-aid to the Government of Manipur under the scheme "A Programme for Juvenile Justice, during the year 2007-08.

Sir,

I am directed to convey the sanction of the President to the grant in aid of **Rs.21,94,605/- (Rupees Twenty One Lakhs Ninety Four thousand Six hundred and Five only)** to the Government of Manipur as Central Share for the current financial year 2007-08 under the Centrally Sponsored Scheme, namely, "A Programme for Juvenile Justice" as per details given below:

2. The above-mentioned grant is subject to the under mentioned conditions:-

Shastri

- (i) An amount of Rs.21,94,605/- represents 45% of State share be allocated by the Government of Manipur from the budget of the State Government for the year 2007-08.
- (ii) The total recurring expenditure that would be required for the maintenance of the institutions had to meet by the State Government.
- (iii) The State Government shall reflect the amount in the audited statement of accounts together with the necessary utilization certificates in respect of the above grant to this Ministry immediately after the close of the current financial year 2007-08.
- (iv) The State Government should certify that the maintenance grant in respect of voluntary organizations are approved by the State Government as required under the juvenile Justice (Care and protection of Children) Act, 2000.
- (v) That no further grant will be released till the utilization certificate and the audited statement of accounts towards grant already released are furnished.

3. The above grant in aid will be released to the **Government of Manipur through CAS, Reserve Bank of India, Nagpur Branch, Nagpur.**

4. The expenditure involved is debitable to Major Head 3601; Grant in aid to State Governments; 04.366-Social Welfare Correctional Services; 02-Prevention & Control of Juvenile Social Maladjustment; 02.00.31- Grant in aid; Demand No.103, Ministry of Women and Child Development for the year 2007-08(Plan).

5. This issues with the concurrence of IF Division of this Ministry vide their Dy.No.784/Dir(Fin)/08 dated 4.3.2008 and Dy. No.2022/JS&FA/08 dated 4.3.2008.
