Subject: Integrated Child Development Services (ICDS) Scheme- Release of grants-in-aid to Government of Puducherry during 2010-2011 for continued implementation of the Scheme –I installment.

Sir,

I am directed to convey the sanction of the President to the payment of Rs. 1,48,32,000/- (Rupees One Crore Forty Eight lakh and Thirty Two Thousand only) to the Government of Puducherry as I installment of grant-in-aid during 2010-2011 for the continued implementation of Integrated Child Development Services (ICDS) Scheme.

2. The expenditure is debitable to the Major Head '3602' in Demand No. 104- Ministry of Women & Child Development under sub-head; 04-Grants for Centrally Sponsored Plan Schemes, 04.358 Social Welfare- Child Welfare, 02-Integrated Child Development Services, 02.01 General Component, 02.01.31 Grants-in-aid 2010-2011 (Plan).

3. The amount of grant-in-aid is finally adjustable in the books of the Principal Pay and Accounts Office, Ministry of Human Resource Development, D, Wing, Ground Floor, Shastri Bhawan, New Delhi. The payment of the State would be arranged through the Reserve Bank of India, Nagpur. The State Accountant General will send intimation regarding receipt of grant-in-aid to the Principal Pay & Accounts Office, Ministry of Human Resource Development, Shastri Bhawan, D Wing, Ground Floor, New Delhi.

4. The State/UT shall maintain separate accounts and furnish information on actual expenditure incurred on ICDS (General) every quarter. The information on expenditure on ICDS (General) from 1<sup>st</sup> April to 30<sup>th</sup> June must be furnished by 15<sup>th</sup> July and for the period from 1<sup>st</sup> July to 30<sup>th</sup> September by 15<sup>th</sup> October and from the period 1<sup>st</sup> October to 31<sup>st</sup> December by 15<sup>th</sup> January and from 1<sup>st</sup> January to 31<sup>st</sup> March by 15<sup>th</sup> April to enable the Ministry to work out the entitlement of Central assistance of the State Government/UT Administration.
