

States/ UTs are requested to intimate the Ministry in case they like to hold exclusive 3 day State specific training for their DPO / CDPOs / Supervisors on *Sabla* and IGMSY, so that the request is forwarded to NIPCCD, New Delhi for organization of the same through the Regional Centres of NIPCCD.
