In the event of any discrepancy/complaint against any firm, the undersigned reserves the right to reject its quotation without assigning any reason therefor.

2. Representatives of firms may visit the stores between 3.30 p.m. and 4.30 p.m. on 16th and 17th November 2009. Items of lab, etc. are lying in Fifth Floor of Krishi Bhawan, New Delhi.
3. The firm shall be required to submit security deposit amounting to Rs. 5000/- in the form of DD/Pay Order in favour of "Pay and Accounts Officer, Ministry of Women and Child Development, New Delhi" along with the sealed quotation. The amount of the security deposit will be released to the firms after finalization of the tender. In case, the first highest bidder failed to pick up the items of obsolete/unserviceable furniture, etc. within two days, the security amount of the firm will be forfeited and the order will be placed to the second highest bidder.
4. The consolidated rates of obsolete/unserviceable items of labs, etc., should be given on firm's letter-head giving address and telephone number of the firm.
5. The firm whose quotation is finalized will be intimated date, time and venue from where the items of lab, etc. are to be handed over to the firm on "**as is where is basis**".
