The quotations should be dropped in the Tender Box kept at the Facilitation Centre, Garage No. 17, Near Gate No. 3, Shastri Bhavan, New Delhi. The cover should prominently super scribe with the words **QUOTATION FOR PURCHASE OF AMBASSADOR VEHICLE**. The vehicle will be available for inspection between 3.00 PM to 5.00 PM on 29<sup>th</sup> & 30<sup>th</sup> September, 2010.

3. The quotations received in time will be opened at 11.30 AM on the same day in Room No. 310, A Wing, Shastri Bhavan, New Delhi in the presence of the bidders or their representative who may wish to be present, if they so desire, at the time of opening of quotation.

4. The sale will be governed by the following conditions:-

- i) The bidder is required to pay Earnest Money of Rs. 5000 payable by means of Demand Draft drawn in favour of PAO, Ministry of Women & Child Development.
- ii) Quotations received without demand draft towards earnest money will not be considered and shall not be accepted.
- iii) The successful bidder will be required to deposit the bid amount by means of Cash/demand draft drawn in favour of PAO, Ministry of Women & Child Development within two working days of the acceptance of the bid.
- iv) The earnest money of the successful bidder will be released only after the deposit of sale proceeds. Earnest Money will be forfeited if he fails to honour the bid.
- v) The delivery of the sold vehicle will be arranged only after the successful bidder submits documentary evidence in support of residential status viz. Ration Card/Voter Identity Card/Passport in case of individual and Registration Certificate in case of firms etc.

vi) The sold vehicle will be removed by the successful bidder within two days of depositing the money at their own expenses.
