Sub.: - Rate quotation for 48 steel racks - reg.

Sir/Madam,

Sealed quotations are invited for procurement and establishment of 48 steel racks (covered by metal sheet from three sides) of size 8'x1.5'x3' (height x depth x width) 14 gauge thickness of shelves in Record Room at Jeevan Deep Building.

2. Interested firms may submit their quotations in the tender box kept in the Information and Facilitation Centre (IFC) of the Ministry at Grd. Floor, near Gate No. 2 at Shastri Bhavan upto 2.00 PM till 5.11.2010. The quotation will be opened at 3.00 PM on the same day i.e. 01.11.2010 by the Tender Committee. A representative of participating company may participate in the Tender Committee meeting. The quotation and supply of the aforesaid article will be governed by the following Terms and Conditions: -

- ix. Earnest Money of Rs.10000/- (Rupees Ten Thousand only) in the form of Account Payee DD, Banker's cheque or a Bank Guarantee in favour of PAO, WCD, New Delhi.
- x. Rate/s should be quoted both in words and figures. Conditional bid will not be accepted under any circumstances and there should not be any erasing or overwriting on the rates quoted.
- xi. If VAT and/or any other tax is payable in addition to the rates quoted, it shall be specifically mentioned otherwise it will be presumed that the rates quoted are inclusive of all taxes.
- xii. No advance payment will be made by the Ministry.
- xiii. The Ministry may finalize the Tender and award the contract without any negotiations, if it is satisfied with reasonableness of the lowest offers. **Therefore, the Bidders are advised to quote lowest possible rates in the first instance only.**
- xiv. The materials provided for making of workstations/storage of files etc. must be with ISI mark and reputed brand.
- xv. If any defect is found in such items, the firm will be responsible to get it replaced from the manufacturing company free of cost.

xvi. Failure to honour the contract would tantamount to forfeiture of EMD and action would be taken to blacklist the firm.
